



Highlighting Vocational Rehabilitation Services

Work Adjustment — During the 4th quarter the consumers were focusing on one thing: employment. The Community Employment Specialists (CES) worked diligently with each consumer to assist them with finding competitive employment based on his/her skills and interest. Several barriers have caused a delay in some of our consumers' chances of being considered or even hired for employment. Those barriers included client's criminal background, limited work experience, and reliable transportation. These barriers can play a major role towards job placement. Employment opportunities were obtained through the following employers: Williamston Yarn Mill (Williamston), Ridgewood Manor Nursing and Rehabilitation (Washington), Food Lion (Columbia), QSI (Lewiston), Zebra Construction (Washington) and Mega Force (Washington). A total of 10 Work Adjustment placements were completed for the quarter along with 10 Major Benefits. To conclude the quarter, 13 Work Adjustment Closures were completed.

<u>Supported Employment</u> – Due to the low number of referrals for Supported Employment, no placements were made during this quarter. However, the 4th Quarter Success Club Meeting was held on

December 6th in Greenville. CES Carter, Jefferson, and Williams along with a consumer, enjoyed a day at the Greenville Mall while the consumer shopped for Christmas gifts, followed by lunch in the food court. The CES's recognized the pictured consumer for his attendance and longevity of employment by awarding him with a Certificate of Appreciation and a Wal-Mart gift card.

CES Carter, Jefferson, and Williams strive daily to help each consumer seek employment, prepare them for interviews, enhance skills needed to obtain and maintain a job, as well as assist with arranging transportation for work.
